A Force for Good for All Arizonans

The heart and soul of OneAZ Credit Union is our membership. We are guided by our mission to improve the lives of our members, our associates, and the communities we serve. Our commitment to you is simple — we aim to help you live a financially independent life and to strengthen your community by supporting local nonprofit organizations. In 2022, our effort to be **“A Force for Good”** in our members’ lives allowed us to achieve many great milestones.

2022 Highlights Include:

Helping more Arizonans achieve their goals.

2022 was a momentous year for our OneAZ family. For the third year in a row, we experienced record growth, welcoming over 23,000 new members to OneAZ and we are now over 161,000 members strong. More Arizonans than ever are finding a home with us because they understand that we exist to improve their financial well-being. Each new member represents a new opportunity for us to serve not only individuals and their families, but their local communities. For every new member that joined us in 2022, we welcome you with open arms and look forward to serving you for years to come.

Members experienced higher savings.

The shifting rate market opened new opportunities for members to earn more from their savings. In 2022, we increased the dividend rates on our savings, money market and Share Certificate accounts to levels that members haven’t seen in years. This new shift in the market is an exciting chance for everyone to establish healthy savings habits. It was especially beneficial for members with lower starting balances, those who previously may have been reluctant to save or those looking for low-risk, high-reward savings opportunities.

Financial education inside the classroom.

Financial education is a key pillar of the credit union movement. In 2022, OneAZ partnered with Banzai to provide financial education curriculum for thousands of Arizona students. Banzai gives teachers the opportunity to use their scenario-based educational tools to teach students real-world applications for budgeting, spending and saving, and even business planning. We started our partnership with 15 schools with plans to expand our outreach to more schools in 2023 and beyond.

A Force for Good in our communities.

The OneAZ Community Foundation touched more lives than ever before in 2022. We donated over \$460,000 to locally based nonprofit organizations — the most we’ve given in a single year. Last year’s giving allowed us to reach \$1,000,000 in total donations since establishing the Foundation in 2016. We also launched a new Legacy Grant program that allows us to support the unique needs of our communities through significant financial commitments.

I am proud to say that our OneAZ family is strong because of our efforts to enhance our members’ lives and build resilient communities. With our commitment to improve lives at the forefront of every decision we make, I am confident that OneAZ will continue to be **“A Force for Good”** for all Arizonans for years to come.

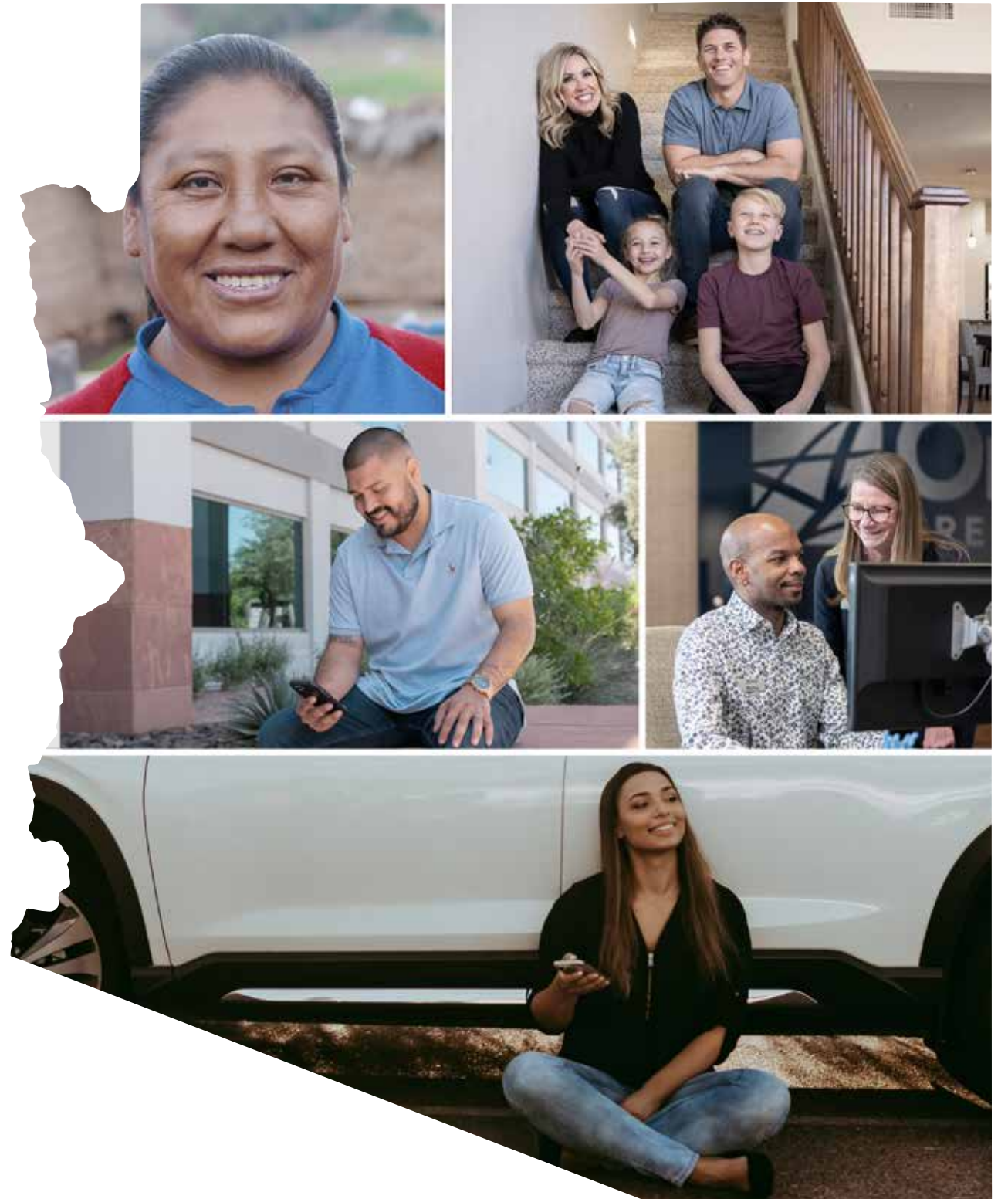

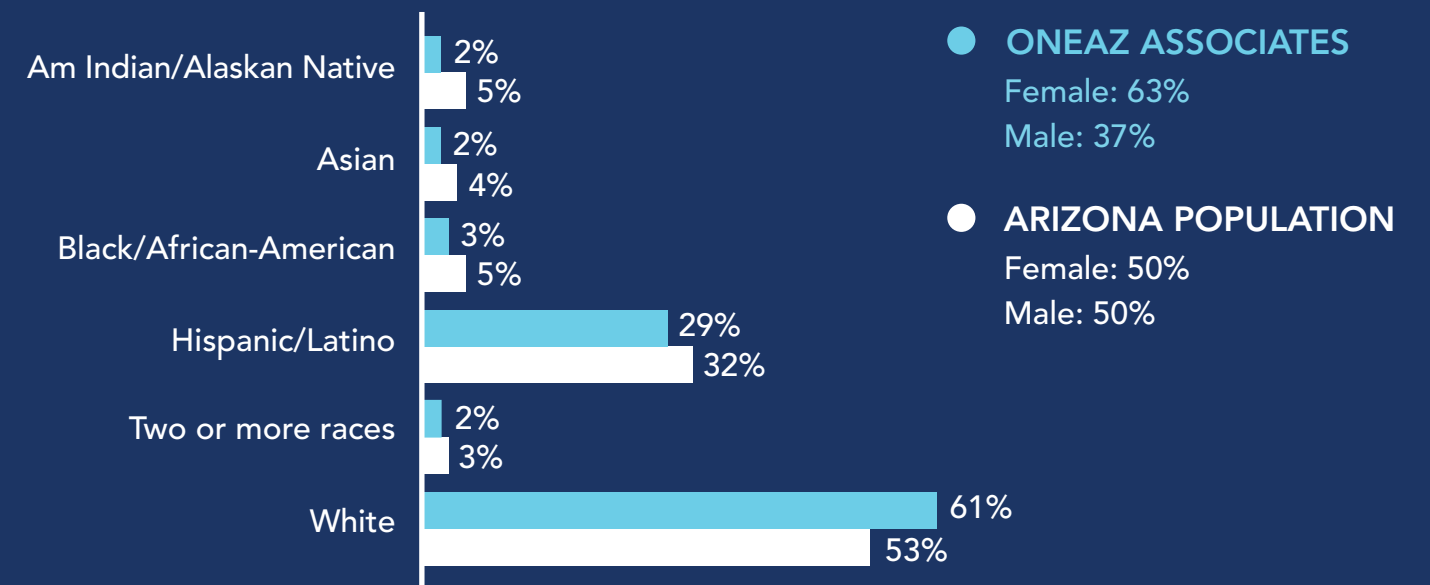

Community Impact Grant Program

The Community Impact Grant program is the cornerstone of the OneAZ Community Foundation's charitable giving. Since 2016, the Community Impact Grant program has helped support hundreds of Arizona nonprofit organizations. In 2022, we increased the amount of each Community Impact Grant from \$2,500 to \$5,000. We were able to expand our giving because of our sustainable model of funding that allows the Foundation to grow as membership grows. Because of members like you, in 2022, we provided 50 Community Impact Grants to Arizona nonprofits for a total of \$250,000!

Their mission is to provide a safe space for students with learning difficulties to learn and fulfill their potential. OneAZ Community Foundation Legacy Grant Stories

In 2022, the OneAZ Community Foundation launched the Legacy Grant program. The Legacy Grant program allows OneAZ to support causes and initiatives that require a financial commitment above and beyond the grants provided in the Community Impact Grant program. Through this new grant initiative, OneAZ is able to make a lasting impact on community organizations that are uplifting the lives of our neighbors.

In 2022, OneAZ provided \$193,000 in funding to 6 organizations through the Legacy Grant program.

Homeward Bound

Homeward Bound provides prevention, shelter, and after-care programs to hundreds of Arizona families experiencing homelessness. Their Legacy Grant will support 160 families in the Phoenix area through Homeward Bound’s Shelter and Community Program. This program provides families with access to an array of services from financial education to youth programs.

Supervisory Committee Report

Your Supervisory Committee is appointed by the Board of Directors and is responsible for ensuring that the assets of OneAZ Credit Union are safeguarded; an independent audit is performed annually; account balances of the membership are verified; and appropriate policies and procedures exist to ensure compliance with management's objectives and regulatory requirements. These responsibilities are accomplished through regular meetings with the Board of Directors, Credit Union management and staff, Risk Management/Internal Audit, external auditors, and regulators to review the Credit Union's activities and audit results.

The Supervisory Committee has concluded that OneAZ Credit Union remains compliant with financial and operational internal controls and applicable regulatory requirements.

As of September 2022, the Arizona Department of Insurance and Financial Institutions and the National Credit Union Administration jointly completed their annual regulatory examination. In addition, Doeren Mayhew, a national CPA firm with recognized expertise in the credit union industry, has been contracted to independently audit the financial statements and to perform member account verification procedures.

The Supervisory Committee has concluded that OneAZ Credit Union remains compliant with financial and operational internal controls and applicable regulatory requirements. We wish to express our appreciation to the Board of Directors, management and staff for their continued cooperation, compliance and dedication to the success of OneAZ Credit Union.

As Treasurer of the OneAZ Credit Union Board of Directors, I am proud to report that OneAZ continues to be a strong, stable, and secure financial institution. In 2022, OneAZ experienced record growth in membership, which is a direct result of our associates' dedication to improving the lives of our members.

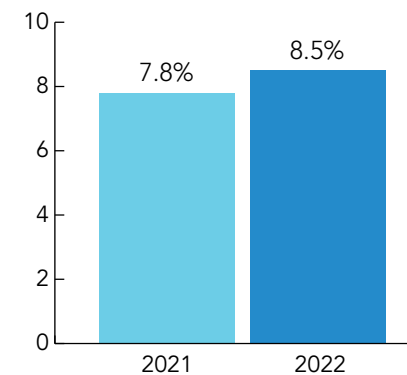
Assets grew by 7.48% to reach \$3.27 billion, and member loans grew to \$1.88 billion — 27.63% increase over the previous year. OneAZ's capital strength of 8.48% exceeds the National Credit Union Administration (NCUA) well capitalized threshold of 7.00%.

In 2022, OneAZ experienced record growth in membership, which is a direct result of our associates' dedication to improving the lives of our members.

OneAZ Credit Union is poised for greater growth in 2023 and beyond. As OneAZ's membership and assets continue to grow, it will drive investment in improved technology, products, and services, which in turn will allow our associates to improve lives and deliver the best banking experience possible.
